7. The Bidders are requested to give their best and final price with Taxes (Must be registered with Income Tax, GST, KPRA etc) for the quoted Works and Purchases as per the Specifications in Part-Two: Section-IV of the Standard Bidding Documents as no negotiations on the price are allowed.
